**PRESENT POSITION OF 78.2% PENSION REVISION FOR CHTD CIRCLE:**

In Chennai Telephone District as on 22.04.2017, Pre 2007 cases of 78.2 have been almost completed (2455 cases) .Only 83 cases are pending for want of files from BSNL pension section. The list of pensioners with details ( name, ppo no: year of retirement etc.) sent to pension section to forward those files to DOT cell for further processing.
